Coastal Cleanup Initiative and Networking BBQ



Trash jeopardizes our ocean, coastline, country parks, economy and people. In Hong Kong, we generate 6 million tonnes of waste per year, but only a small portion is recycled. Our landfills are almost full and it's time for us to make a change.

Come and take part in the <u>Hong Kong Cleanup Challenge</u> which has engaged over 270,000 participants and cleaned up over 22 million pieces of trash since 2000.

It is not only a meaningful activity for protecting our environment, but also a networking opportunity with fellow young members. Participants will work in teams to help clean up the beach and participate in friendly competition to understand more about the coastal trash issues.

A networking BBQ will follow after the cleanup activity.
