Each player plays 3 games per session, with a handicap in each session.</li> <li>At least half of each team's league games, i.e. 54 out of 108 games (3 games x 3 players x 12 sessions), must be played by HKICPA members.</li> <li>Detailed league rules will be distributed to registered players.</li> <li>(* To comply with the lane booking requirement, at least one member of each team needs to be a current member of SCAA. If none, one of the teammates has to join SCAA membership, whose annual fee is HK\$100 for ordinary member.)</li> </ul>
