1. 《中國註冊會計師》(2017年1月至12月 - 共12期)

The Chinese Certified Public Accountant (Jan – Dec 2017 for 12 issues)

《中國註冊會計師》月刊是由財政部主管、中國注冊會計師協會主辦的國家一級刊物,曾入撰為《中文核心期刊要目總覽》會計類核心期刊。

《中國註冊會計師》旨在探討註冊會計師的執業問題,促進註冊會計師業務質量提高;研究註冊會計師行業理論,探索註冊會計師行業發展規律;發佈國家最新法律、法規和方針、政策;展示行業發展和協會建設成果。月刊的內容更涵蓋與註冊會計師業務相關的政策法規和專業標準、會計、審計、鑒證、法律與稅務的實務探討;案例研究、會計師事務所的管理、考試及行業資訊等。

2. 《中國稅務》(2017年1月至12月 - 共12期) China Taxation (Jan - Dec 2017 for 12 issues)

《中國稅務》雜誌於 1984 年創刊,由國家稅務總局主管,是內地目前最具權威性的稅收專業期刊,先後獲得百種全國重點社科期刊、國家期刊獎、中國百強報刊等殊榮。

《中國稅務》提供集中、系統性的內地稅務時評、稅務要聞、政策解讀、業務指南、案例分析等專題評論和報導。

3. 《國際稅收》(2017年1月至12月 – 共12期) International Taxation in China (Jan – Dec 2017 for 12 issues)

《國際稅收》雜誌是內地唯一有關國際稅收的專業期刊,曾榮獲第三屆國家期刊獎百種重點期刊稱號。

《國際稅收》致力發展成為中國內地稅收與國際稅收交流合作的媒體平台,一方面向內地介紹國際稅收理論成果和資訊、外國稅制和管理等新經驗,同時對外展現內地的稅制改革進展、徵管成就及各項稅收工作狀況。《國際稅收》的內容包括各地和跨境的稅收專題、稅收實務、案例點評、國際稅事評說等。
