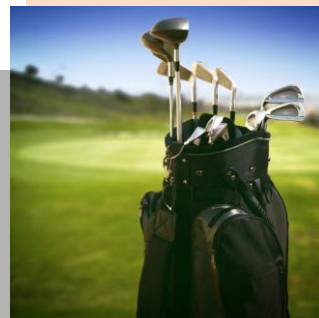




# Advanced Short Game
