- A Start to Coffee

Ask any coffee lover, and they will tell you that brewing the perfect cup is an art many people never master completely. It's much more than buying the finest coffee beans. Factors such as the coffee grounds to water ratio, water quality and temperature, and the brewing methods all play a role in determining the quality of the cup.

Different brewing methods can bring out different qualities even when using the same type of coffee beans. It is very easy to ruin coffee if the brewing is not done properly.

During the talk, coffee ambassadors from Pacific Coffee will not only brief you on the history of coffee, its processing and roasting, but they will also demonstrate different brewing methods. Towards the end of the session, you will get to taste coffee from two single origins prepared in two different methods.
