



The new Auditor's report - Effective implementation of the new and revised Auditor Reporting standards

The auditor's report is the key deliverable communicating the results of the audit process. Investors and other financial statements users have asked for a more informative auditor's report, in particular for auditors to provide more relevant information to users. Effective implementation is critical to the success of the new and revised Auditor Reporting standards which became effective for audits of financial statements for periods ended on or after December 15, 2016. The workshop aims to assist participants in understanding the key changes of the new auditing standards and to help participants in re-vamping the **New Auditor's Report**, such as how to identify the **Key Audit Matters** in the audit and how to address them in the published reports, to understand the nature and requirements and also the responsibilities of management, directors and auditors for the new "**Other Information**" section and other significant changes to the auditor's report.
