ABOUT THE SEMINAR

In December 2016, [Meitu](#), the Chinese photo-editing app maker, launched an initial public offering in Hong Kong and is now with a market capitalization of HK\$50 billion. However, Hong Kong as a listing venue for tech companies has not always been an obvious choice, and listing with negative profits and cash flow is not a common practice in Hong Kong either.

Using Meitu's IPO as a backdrop, Mr. Gary Ngan, CFO and Joint Company Secretary of Meitu, Inc. will share his experience in navigating through the listing process, communication strategies with investors in both the East and the West, as well as his vision of the future tech sector in the Hong Kong equity market.
