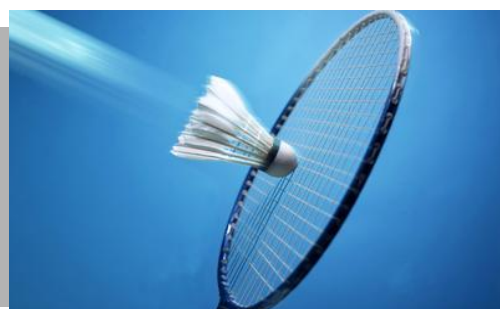




## Badminton Technique Training Course
