Entry requirement:	Able to swim 50 metres.

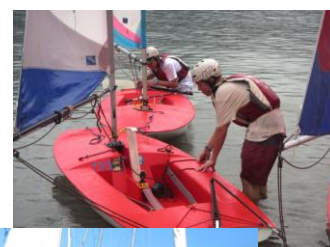
