- The event is subject to rescheduling due to poor weather conditions.



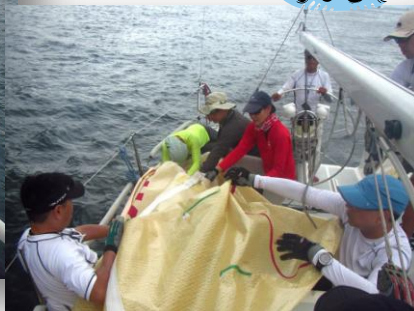
