Workshop outline

Business and organizational leaders who work in teams have to collaborate with people within and out of the organization whom you may not have formal authority to command their co-operations.

Leadership has been evolving since the era of manufacturing where the leadership style of command and control was the norm. As the economy is becoming more service-driven, leaders need to be able to engage and empower their staff so that swift and effective decisions can be made in a timely manner.

Today, technology has enabled organizations to work in a globalized manner, and more matrixed organizational structures require a great deal of coordination: that is, one needs to organize work so that good things happen — whether you are in control or not. Also, the more widely spread and looser organizations today require that leaders cultivate and coordinate effectively so as to encourage people's capabilities and ideas — whether they report to you or not.

This workshop aims to provide an updated framework with principles and techniques for matrix leaders to navigate within and out of the organization so that people with whom you do not have any formal authority upon will collaborate to achieve the desired business results. It covers:
