



## Football Team Recruitment



The **Football Interest Group (FIG)** is inviting members to form a team to participate in either 7-a-side or 11-a-side league to be held between August 2017 and July 2018.

**Target participants:** Members who are football enthusiasts and have a strong sense of team spirit

**Purposes:** Mainly to provide more opportunities for members to enjoy the competitive games and improve football skills together with their fellow members.

**Dates:** Matches will be arranged on Monday to Saturday evening and Sunday afternoon.

**Fee:** **\$500** is payable by each team member to cover the league expenses including the team uniform.

**Capacity:** Min. 40 for 7-a-side league / Min. 60 for 11-a-side league

**Remarks:**

- Joining a 7-a-side or 11-a-side league is based on the choice of the majority members.
- Due to the LCSD booking policy, the match information can only be available 9 days before each match. In line with other IG event's registration procedures, an email will be sent to team members upon receipt of the match information from the organiser.
- Each team member should confirm his availability as soon as possible through an on-line registration system. All team members are expected to show their utmost team spirit by commitment.
- During each match, the FIG Convenor, Mr. Tom Ho or the appointed on-site supervisor will be in charge of the squad rotation from the tactical viewpoint.
- For easy communication and logistical arrangements, Tom will use WhatsApp to communicate with team members. Please indicate if you wish to join this WhatsApp group in the event your application is successful.

4. The closing date for enrolment is **24 July**. However, the Institute has the discretion to accept late enrolments as it sees fit.
5. Registration by fax will ONLY be processed when payment is made by credit card. Cash is strictly NOT accepted.
6. Successful registrants will receive confirmation by email or by telephone, whereas unsuccessful registrants will receive full refund.

8. Unless the activity is cancelled due to unforeseen circumstances, low enrolment or bad weather, no refund for withdrawal will be entertained after the enrolment has been processed.
