



HKICPA e-seminar: IFRS 17 "*Insurance contracts*" in a nutshell (audio)



This e-seminar assumes that the audience has experience and knowledge in the insurance industry, and is suited for auditors, accounting/ finance personnel and CFOs in the insurance industry.

In May 2017, the IASB issued a new accounting standard IFRS 17 Insurance Contracts, which will replace IFRS 4 Insurance Contracts on 1 January 2021. It is expected that the Hong Kong equivalent standard will be issued soon.

IFRS 17 will dramatically change the way insurance companies account for insurance contracts. To implement IFRS 17, insurance companies will need to make major changes to their actuarial and finance reporting processes, systems and data.
