- Rest point at Quarry Gap (aka Tai Fung Au) at the intersection of Hong Kong Trail section 5 and 6
- Tai Tam Upper Reservoir
- Tai Tam Main Reservoir
- Dismiss at Tai Tam Reservoir bus stop

Difficulty: 2 (1 = easiest; 5 = hardest)

- Participants are recommended to bring at least 1.5-litre water/sports drinks, snacks, sun block lotion, hat / umbrella, and hiking pole(s).
- Participants must be fully prepared with proper gear, and physically fit to undergo the activity.
