

Swimming Classes



We are pleased to offer the following structured swimming classes in response to members' demand:

B	8:00 – 9:00 pm Every Thursday	Beginner, Intermediate & Advanced swimmers	Any 5 sessions between 4 January and 8 February 2018

Venue: **Victoria Park Swimming Pool**, 1 Hing Fat Street, Causeway Bay, Hong Kong

***Regular maintenance of Victoria Park Swimming Pool will be performed from 22 February to 23 April.*

Fee: HKICPA members: \$500

Non-HKICPA members: \$550

Fixed fee with no pro rata payment or refund for not being able to attend all sessions.

Entrance fee to the swimming pool is included.

Capacity: Min. 4 persons (max. 12 persons) for each class

Remarks:

- Hoi Tin Swimming Consultants Limited is the service provider
- The classes are conducted in Cantonese
- No classes will be held on public holidays
- Students can make up classes with the other section if necessary



About the courses

Beginner

- For members who are non-swimmers or have very rudimentary swimming skills
- Covers pool safety, basics of floating, movement and control in the water

Intermediate

- For members who are able to swim at least one stroke - freestyle or breaststroke
- Covers improving all around swimming technique and backstroke

Advanced

- For members who are well rounded in at least three competitive strokes
- Covers swimming technique improvement for all four strokes

Two 25m lanes will be used exclusively for the training. Experienced swimmers (intermediate and advanced levels) and novice players (beginner level) will be trained separately in different lanes by different coach. Trainers will teach based on individuals' level and capability. Swimmers are encouraged to learn a new swimming style one after the other. In response to member's comments, Hoi Tin will try to book three lanes for the season starting from mid-April 2018, subject to lane availability.
