Objectives

It is a revision course mainly designed for those students prepared to take Paper P3 – Risk Management Exam for CIMA membership and CGMA. The course will include:

- Identification, classification and evaluation of risk;
- Responses to strategic risk;
- Internal controls to manage risks;
- Managing risks associated with cashflows; and
- Managing risks associated with capital investment decisions.

Live examples will be shared during the course to illustrate the concepts. Session 6 will focus on the exam techniques, solely for those interested participants to prepare for the P3 examination.

Note

- 1. Under the Mutual Examination Paper Exemption agreement between HKICPA and CIMA, all HKICPA members are exempted from 15 out of 17 papers of CIMA examinations and have to pass Paper P3 Risk Management Exam and the Strategic Case Study Exam for acquiring CIMA membership and CGMA, subject to the fulfilment of practical experience.
