## Two-day Lotus Photography Tour



The **Photography Interest Group (PoIG)** has organized a two-day trip to Foshan and Dongguan (佛山及東莞) for members who are interested in lotus photography. Participating members will have a chance to learn the practical shooting skills and techniques from a professional photographer, Mr. Raymond Lo, during the trip.

**Date:** 23 – 24 June 2018, Saturday and Sunday

**Capacity:** 20 participants

**Fee:** **\$1,180 (HKICPA member)**  
**\$1,240 (non-HKICPA member)**

- ✧ Fee includes adviser's fee, meals, hotel accommodation for one night, transportation in PRC, admission fees to all scenery spots, tips to the tour guide and driver.
- ✧ Travel insurance of HK\$100,000 is included except for participants over 70 years of age
- ✧ The fee is on a room sharing basis. There is a surcharge of \$250 for single room.
- ✧ Meals include 1 breakfast, 2 lunches and 1 dinner.
- ✧ Tour fee paid will not be refunded unless the tour is cancelled due to typhoon No. 8 or black rainstorm signal.

- Cantonese is the medium of the activity.
- Participants should bring their own digital single-lens reflex camera (DSLR), telephoto lens (preferably from 200 mm - 500 mm), reflex lens (if any) and tripod.
