### **About the Tournament**

- 1. The tournament is a pair game tournament.
- The combination of the pair can be (a) two members, or (b) one member and one QP student/graduate.
- 3. Either pair or individual entry is welcome. In the latter case, the Institute will do the pairing-up on a random basis.
- 4. One entry form per individual / pair entry.

## **Awards**

Trophies will be awarded to the champion, 1st runner-up and 2nd runner-up pairs.

### **Format**

While the match point scoring will be adopted, the format of the game is subject to the final number of players and will be determined by the tournament director as he deems appropriate.

## No show penalty

As it is a pair game tournament, therefore any registered player who do not show up at the tournament will jeopardize his/her partner to take part in the tournament. To ensure a smooth running of the tournament, the Institute will at its discretion to impose a penalty to the defaulter in the form of barring him/her from entering into the next CPA Bridge Tournament, unless a replacement is found in time to enable the tournament to proceed without disruption.

- 1. Enrolment for the competition is accepted on a first-come-first-served basis with priority given to Bridge Interest Group members.
- 2. Full payment must be made before your enrolment will be processed. No telephone reservation will be accepted.
- 3. The closing date for enrolment is 7 May 2018. However, the Institute has the discretion to accept late applications as it sees fit.
- 4. Application by fax will ONLY be processed when payment is made by credit card, Cash is strictly NOT accepted.

- 6. Unless the activity is cancelled due to unforeseen circumstances, bad weather or low enrolment, no refund for withdrawal will be entertained after your enrolment has been processed.
