- 3. Full payment must be made by cash before your enrolment. For the enrolment by fax, the enrolment fee will be collected at the first lesson of such training course. No telephone reservation will be accepted.
- 4. The Convenor has the discretion to accept late enrolments after the closing deadline as it sees fit.
