About the Dance Competition

The competition has two categories:

Latin: Cha Cha Cha & Rumba

Ballroom: Waltz & Tango

- At least one person in each pair must be a Hong Kong Institute of CPAs member.
- Member should register online with particulars of his/her partner, who can be a non-member.
- A contestant can join more than one category with different partner.
- As this is a competition for members, their score will take up the majority of the total score.
- There is no restriction on gender for competition entry. In other words, a couple can be in the same gender or different gender.
- There is no fixed choreography or syllabus. Judges will look for members' posture, timing, line, hold, poise, musicality and expression, foot and leg action, lead and follow and floor craft. Judges' decisions are final and no appeal will be entertained.
- The duration of each dance is approximately 2 minutes.
- The entire competition including prize presentation will take place at the Dance Fun Night on 15 September 2018. First, second and third place will be awarded with trophies/medals.
- No entry fee is required to enter into this members' competition.
- Deadline for entry is **29 August 2018**.
- The competition will be cancelled if there are less than 4 entries for each category. Subject to the final number of entries, the competition may be divided into preliminary and final rounds to be held in the same evening.

Terms for Enrolment in Sports IG Activities

Any enrolment in the activity is based on the participant's assessment that s/he is fit to participate and the assumption of all the risks and hazards inherent in the said activity. The participant agrees not to hold HKICPA or the convenor of the interest group liable for any loss or damage that the participant may suffer as a result of the participation.

The participant further agrees to follow the instructions from trainers (if any) and any failure to follow such instructions will result in the participant's exclusion from the activity. 1. Priority for enrollment will first be offered to DIG members and then to non-DIG HKICPA members in the case of over subscription. We only consider non-member's enrolment when it is enrolled with a member.
2. This event is subject to cancellation should the minimum number is not reached.
3. The Convenor has the discretion to accept late enrolments after the closing deadline as it sees fit.
4. Unless the activity is cancelled due to unforeseen circumstances, low enrollment or bad weather, no refund for withdrawal will be entertained after the enrollment has been processed.
5. Bad weather arrangement: The activity will be cancelled if typhoon signal no. 8 or above / Black Rainstorm Warning is hoisted at or after 2:30 pm on the date of the activity.
6. The Convenor reserves the right to change the venue and date of the event due to unforeseen circumstances.
