

Golf day at Kau Sai Chau (South/East Course)

The **Golf Interest Group (GIG)** has organized a golf day at Kau Sai Chau for different levels of players. The **South Course** is more player friendly for beginners or high-handicappers while the **East Course** is more challenging for experienced players.

Details

Date: 25 August 2018, Saturday

Time: South Course - First tee off time at 8:34 am
East Course - First tee off time at 8:33 am

Venue: Jockey Club Kau Sai Chau Public Golf Course (KSC), Sai Kung

Handicap South Course - Men at 36.4 or below and Ladies at 40.4 or below Note 1

Requirement: East Course - Men / Ladies at 30 or below Note 2

Participants are required to indicate whether they have the KSC Golf Pass Certificate, or latest official

handicap index (issued by HK Golf Association or other recognized golf associations/clubs).

Capacity Min. 12 players (either one course or two courses together)

Fee:

	Below 60 years of age (South course / East course)	60 years of age and over (South course / East course)
Green fee	\$800 / \$900	\$800 / \$900
Ferry fee	\$75	\$40

Lunch: Lunch will be at players' own expenses.

Car pool: Subject to demand and volunteering service by players.

Remarks:

• The event will be cancelled if there are less than 12 players, or requisite handicap requirement Note 182 is not met

(Note 1: 25% of the players; Note 2: 50% of the players)

- KSC provides complimentary use of electric golf cart on a sharing basis (not allowed on fairways or areas with turf). Golfers under 18 years of age are not permitted to drive electric golf cart.
- In accordance with Road Traffic (Village Vehicle) Regulations, all golf cart drivers must hold a valid driving license.
- · No caddy service is provided.
- · Ferry service departing from Sai Kung at 20-minute interval, on the clock, 20-min past and 40-min past.
- Assemble near the Course Reception Counter on G/F, Administration Building. Exact time is to be advised.
- Players are required to bring their own golf gear (clubs, gloves, balls, tees, etc), and wear proper golf shoes and attire.
- · Complimentary use of locker/changing room facilities available.
- The course will be closed when signal no.3 / Black rainstorm / lightning / or any unforeseeable dangers. Under these circumstances, the golf day will be totally refunded.
- KSC policy does NOT offer refund for late cancellation and/or no-show after confirmation.

- 3. Full payment must be made before your enrolment will be processed. No telephone reservation will be accepted.
- 4. The Convenor has the discretion to accept late enrolments after the closing deadline as it sees fit.
- 5. Unless the activity is cancelled due to unforeseen circumstances, low enrollment or bad weather, no refund for withdrawal will be entertained after the enrollment has been processed.
- 6. Bad weather arrangement: The activity will be cancelled if typhoon signal no. 8 or above / Black rainstorm warning is hoisted 2 hours prior to assembly time.
