The **Football Interest Group (FIG)** is recruiting team members to participate in a 7-a-side or 11-a-side league. Competitions will be held between August 2018 and July 2019.

Who should join Members who are football enthusiasts and have a strong sense of team spirit

Objective Provide opportunities for members to enjoy the competitive games and improve their football skills while playing with fellow members

Date Matches will be arranged on Monday to Saturday evening and Sunday afternoon

Fee **\$550** - league expenses including venue rental and referee fee
\$310 - team uniform (for those who did not join the league in 2017-18)

Capacity Min. 40 for 7-a-side league and 60 for 11-a-side league

Remarks

- The joining of a 7-a-side or 11-a-side league will be based on a majority vote among team members.
- Owing to LCSD booking policy, the league organizer will announce each match 9 days before the competition, and members will receive a notification email in due course.
- Team members are required to confirm his availability through an online registration system or the league's WhatsApp group prior to each match. All team members are expected to show their utmost team spirit by commitment.
- The FIG Convenor, or a person appointed by the convenor in his absence, will be the team captain and be in charge of squad rotation from a tactical viewpoint during each match. Members should abide by the team captain's decision.
- The convenor will create a WhatsApp group to facilitate communication with team members. Please indicate if you wish to join the WhatsApp group in the event your application is successful.

4. The closing date for enrolment is **21 July**. However, the Institute has the discretion to accept late enrolments as it sees fit.
5. Registration by fax will ONLY be processed when payment is made by credit card. Cash is strictly NOT accepted.
6. Successful registrants will receive confirmation by email or by telephone, whereas unsuccessful registrants will receive full refund.
