# Managing IT Risks and Digital Risks (SCPD18082001)

### **Course outline**

Information Technology (IT) is now widely used in all industries – from government departments to financial institutions, and in all areas – from finance department to customer services over mobile apps. While many organizations are enjoying the benefits with the use of IT, many fail to clearly identify, fully understand and properly manage various IT risks. The impact of failure to manage IT risks ranges from lack of efficiency or unnecessary manual process to significant reputational and/or financial damage. More importantly, the tasks of managing IT risks should not be rested solely on the shoulder of the IT department. It is equally important for CEO, CFO, as well as auditing/compliance team to understand ways to manage IT risks.

Digital transformation or the implementation of disruptive technology could revolutionize ways of businesses' own operations as well as providing products and services to their clients. Similar to the implementation of traditional IT systems, using of digital transformation also presents challenges and risks to organizations. Success in managing the associated risks often is the key success factor of the use of digital technologies.
