Notes:

1. Priority for enrollment will first be offered to TsIG members and then to non-TsIG HKICPA members in the case of over subscription. Non-members' applications will only be processed after registration deadline subject to availability. We only consider non-member's enrolment when it is enrolled with a member.
2. This event is subject to cancellation should the minimum number is not reached.
3. Full payment must be made upon confirmation of your enrolment. No telephone reservation will be accepted.
4. The coach has the discretion to accept late enrolments after the closing deadline as it sees fit.
5. Unless the activity is cancelled due to unforeseen circumstances, low enrollment or bad weather, no refund for withdrawal will be entertained after the enrollment has been processed.
6. Bad weather arrangement: The activity will be cancelled if typhoon signal no. 8 or above / Black Rainstorm Warning is hoisted 1.5 hours prior to the commencement of the course.
7. The coach reserves the right to change the venue and date of the course due to unforeseen circumstances.
