About the programme

Unveiling the Tricks of Equity Fund Raising Actions of HK-listed Companies (拆解上市公司財技: "拆·合·削·供·送" 抽水大法) (WSHP18101001)

This workshop will focus on the rationale of corporate actions of listed companies in Hong Kong and China. The speaker will cover various equity fund raising activities commonly employed by listed companies, distinguish the pros and cons of different equity fund raising activities and unveil the financial gimmicks of various corporate actions of listed companies.

Topics include:

- Review of major equity fund raising activities of HK listed companies, including Rights Issue ,Open Offer, Share Placing and Consideration Issue
- Understand the rationale behind each type of fund raising activities
- Insight of the implications of a "combination" of various types of fund raising corporate actions
- Analyze the risk and reward mechanism from both listed corporate and investors' perspectives
- Case studies

After joining this workshop, participants will:

- Understand the rationale behind each type of equity fund raising corporate action
- Unveil the financial gimmicks of the "combination" of various equity fund raising actions
- Know how to analyze the risk and reward mechanism of various fund raising corporate actions from corporate and investors' perspectives



Analyzing Financial Statements for Accountants (re-run) (WSHP18102001)

This workshop will focus on analyzing and interpreting financial ratios.

Topics include:

- Evaluate financial risks pre- and post-financial tsunami
- Identify the financial characteristics of various industries
- Assess financial risks of a company using ratio analysis
- Interpret and analyze the top ten financial ratios commonly used by analysts
- Identify repayment source using cash flow statements
- Case studies

Continuing Obligations of Listed Company under Chapter 13 of the Main Board Listing Rules (WSHP18103001)

This workshop is specially designed for accounting, corporate finance professionals and company secretaries who wish to learn practical hands-on knowledge and experience regarding the compliance requirements set out in Chapter 13 of the Main Board Listing Rules. The speaker will demonstrate by using practical examples and cases as well as share experience and tips in relation to continuing obligations of listed companies under Chapter 13 of the Main Board Listing Rules.

Topics include:

- Review the general obligation of disclosure of inside information
- Apply the disclosure of unusual movements in price and/or trading volume of listed securities
- Understand trading halt and trading suspension
- Analyze the compliance issues in relation to advance to an entity, financial assistance and guarantees to affiliated companies, pledging of shares by the controlling shareholder, loan agreement with covenants relating to specific performance of the controlling shareholder and breach of loan agreement
- Apply the disclosure requirements in relation to issue of shares and securities
- Maintain public float requirements and avoid high concentration of shareholding
- Notification of any corporate changes of listed companies
- Evaluate other compliance issues under Chapter 13 of the Main Board Listing Rules

After joining this workshop, participants will:

- Understand the compliance issues of Chapter 13 of the Main Board Listing Rules
- Able to prepare announcements, circulars, reports, checklists and forms required by the Stock Exchange of Hong Kong
- Know how to ensure proper documentation and disclosure
- Know how to respond to enquiries by the Stock Exchange of Hong Kong and other regulatory bodies



Understanding Facility Letter and Term Sheet for Accountants (re-run) (WSHP18110301)

This workshop introduces and interprets the key terms and conditions in a bank's facility letter and term sheet.

Topics include:

- Outline of a bank's facility letter and term sheet
- Basic credit terms - facility types, pricing, price protection clause and repayment and prepayment term
- Amendments and waivers - all lenders' consent vs. majority lenders' consent
- Representations and warranties
- Three types of covenants - affirmative covenants, negative covenants and financial covenants
- Events of default - occurrence and remedies

Understanding Securitization for Accountants (re-run) (WSHP18112402)

This workshop introduces the fundamentals, rationales, credit enhancement techniques and common issues with securitization.

Topics include:

- Fundamentals of securitization
- Securitization from investors' and originators' perspectives
- Securitization as a balance sheet management
- Credit enhancement techniques
- Common issues with securitization
