Accounting and financial reporting: HKFRS 15 Revenue from contracts with customers (Re-run)

COURSE HIGHLIGHTS:

HKFRS 15 Revenue from contracts with customers became effective on 1 January 2018. The new standard introduces a five-step model which entities will need to apply when determining when to recognise revenue, and at what amount. HKFRS 15 also contains new qualitative and quantitative disclosure requirements regarding the nature, amount, timing and uncertainty of revenue arising from these contracts.

This seminar aims to illustrate the application of the 5-step approach introduced by HKFRS 15 using various practical examples, focusing on how certain new requirements and guidance may impact entities upon application of the standard, what are the transition options available, and discuss some of the potential misconceptions that entities may experience when implementing HKFRS 15.
