- The Airport Authority Hong Kong ("AAHK") requires participants to provide their names (Chinese and English) shown on the Hong Kong Identity card ("HKID card"), HKID card no., business position and contact no. to apply for the airside permits. If the name does not match with their HKID card, participants will not be allowed to enter into the visiting places. On the event date, AAHK will check participants' HKID card before issuing the temporary visitor pass.
- Enrolment for the activity is accepted on a first-come-first-served basis. Priority will be given to young members (i.e. aged 40 or below), in the case of over-subscription.
- 3. Full payment must be made before your enrolment will be processed. No telephone reservation will be accepted.
- Application by fax will ONLY be accepted when payment is made by credit card. Cash is strictly not accepted. Confirmation of enrolment will be sent to you via email before 29 October. - In normal circumstance, the admission fee is non-refundable or non-transferrable upon receipt of payment by HKICPA.
