Competition: Men's Singles, Women's Singles, Men's Doubles, and Mixed Doubles

Information:

- Minimum entries for each singles and doubles event is 4 or the event will be cancelled
  Maximum entries for singles events is 32 while doubles is 12, subject to change based on the final enrolments
- Each player can join up to 3 events
- The competition will be cancelled when there are less than 2 events
- Enrolment is accepted on a first-come first-served basis

Fee: **\$100** for ONE event; **\$120** for more multiple events

Awards: Champion, 1<sup>st</sup> Runner-up, 2<sup>nd</sup> Runner-up and 3<sup>rd</sup> Runner-up

#### Match format

- 1. Contestants will be divided into groups and matches will be conducted in round robin in the preliminary round. Thereafter, the playoffs will be by single knock out. The number of matches varies according to the number of contestants registered.
- 2. Event(s) with less than 6 contestants will be played on single round robin basis.
- 3. There will be 5 games of 11 points in each match. Contestant(s) who wins 3 games first will win the match.
- 4. The match formats may vary subject to the final number of contestants. Detailed match formats will be announced in due course.
- 5. All matches will be conducted and supervised by professional umpires whose decisions are deemed to be final. No appeal will be entertained.

#### Terms for Enrolment in Sports IG Activities

Any enrolment in the activity is based on the participant's assessment that s/he is fit to participate and the assumption of all the risks and hazards inherent in the said activity. The participant agrees not to hold HKICPA or the convenor of the interest group liable for any loss or damage that the participant may suffer as a result of the participation.

The participant further agrees to follow the instructions from trainers (if any) and any failure to follow such instructions will result in the participant's exclusion from the activity. The convenor of the interest group or trainer (if any) may determine, in the interests of safety or other considerations, whether an activity shall continue or whether a particular participant is allowed to continue to participate.

- 1. The competition is subject to cancelation should the minimum number is not reached.
- 2. Full payment must be made before your enrolment will be processed. No telephone reservation will be accepted.
- 3. The closing date for enrolment is <u>3 December</u>. However, the Institute has the discretion to accept late enrolments as it sees fit.
- 4. Registration by fax will ONLY be processed when payment is made by credit card. Cash is strictly NOT accepted.
- 5. Successful registrants will receive confirmation by email or by telephone, whereas unsuccessful registrants will receive full refund.
- 6. If you do not hear from us by 7 December, please contact Ms. Wong Wan Ki at 2287 7017.
- 7. Unless the activity is cancelled due to unforeseen circumstances, low enrolment or bad weather, no refund for withdrawal will be entertained after the enrolment has been processed.
- 8. Bad weather arrangement: The activity will be cancelled if typhoon signal no. 8 or above / Black Rainstorm Warning is hoisted 2 hours prior to the commencement of the activity.
- 9. The Institute reserves the right to change the venue and date of the event due to unforeseen circumstances.
