15 & 22 February; 1, 8 & 15 March
- Time:** 8:00 pm – 10:00 pm (starts promptly at 8:00 pm)
- Venue:** South China Athletic Association Bowling Centre (SCAA)
- Assembly time and place:** 7:30 pm at Section A area of SCAA

- HKICPA members: **\$1,900**; Non-HKICPA member: **\$2,000**
 - Fixed fee. No pro rata payment or refund for not being able to participate in all sessions.

- Min 8 teams (max 10)
- Format:**
- Each team comprises of 3 players, at least two players must be HKICPA members. A team can have a maximum of 3 reserve players; HKICPA members or non-members are both permitted.
(* Individual players will be grouped together to form a team.)
 - A total of 12 sessions will be held in the league season. Each player plays 3 games per session, with a handicap in each session.
 - At least half of each team's league games, i.e. 54 out of 108 games (3 games x 3 players x 12 sessions), must be played by HKICPA members.
 - Detailed league rules will be distributed to registered players.
(* To comply with the lane booking requirement, at least one member of each team needs to be a current member of SCAA. If none, one of the team members has to join SCAA membership at his/her own cost at HK\$120 for ordinary member.)

2. This event is subject to cancellation should the minimum number is not reached.
3. Full payment must be made before your enrolment will be processed. No telephone reservation will be accepted.
4. The closing date for enrolment is **28 Nov**. However, the Institute has the discretion to accept late enrolments as it sees fit.
5. Registration by fax will ONLY be processed when payment is made by credit card. Cash is strictly NOT accepted.
6. Successful registrants will receive confirmation by email or by telephone, whereas unsuccessful registrants will receive full refund.
