7:30 am - Shuttle bus departs from Huanggang
8:45 am - Tee off (1st flight)
4:30 pm - Shuttle bus leaves PHGC for Huanggang

Venue: **Phoenix Hill Golf Club (鳳凰山高爾夫球會), Fenggang, Dongguan, China**

Fee: **HK dollar* equivalent to RMB950** / player (*at exchange rate prevailing at payment demand date which is normally one week before the event date)
- Inclusive of land transportation in Mainland, caddie, locker and golf cart on a sharing basis.
- Extra cost of RMB100 for player who uses golf cart on his/her own.
- Traveling expenses to Huanggang, food costs and other expenses at the golf club will be at players' own account.

Note:

- Registration is on a first-come-first-served basis and will only be confirmed upon payment of full enrollment fee to the deputy convenor.
- Enrollees are required to make payment to deputy convenor by means of PayMe (9757-6622), or deposit into the deputy convenor's bank account (Stanley Wong: **Hang Seng Bank: 024-204-354336-888**) and have the deposit slip sent to deputy convenor ASAP to secure valid registration.
- No refund for withdrawal but replacement is allowed. The withdrawing player is responsible for finding his/her replacement. Players are allowed to post in the GIG WhatsApp chat group to look for replacement. The withdrawing player and replacing player are required to settle pre-paid enrollment fee on their own.
- Name of replacement has to be given to the deputy convenor at least one day before event date.

Terms for Enrolment in Sports IG Activities

Any enrolment in the activity is based on the participant's assessment that s/he is fit to participate and the assumption of all the risks and hazards inherent in the said activity. The participant agrees not to hold HKICPA or the convenor of the interest group liable for any loss or damage that the participant may suffer as a result of the participation.

The participant further agrees to follow the instructions from trainers (if any) and any failure to follow such instructions will result in the participant's exclusion from the activity. The convenor of the interest group or trainer (if any) may determine, in the interests of safety or other considerations, whether an activity shall continue or whether a particular participant is allowed to continue to participate.

Notes:

1. Priority for enrollment will first be offered to GIG members and then to non-GIG HKICPA members in the case of over subscription. Non-members' applications will only be processed after registration deadline subject to availability. We only consider non-member's enrolment when it is enrolled with a member.
2. This event is subject to cancellation should the minimum number is not reached.
3. Enrollees are required to make payment to convenor by means of PayMe or deposit into the convenor's bank account and deposit slip sent to convenor prior to the event at least 3 days prior to the commencement of the event to confirm his/her registration.
4. No refund for withdrawal but replacement is allowed. The withdrawing player is allowed to post in GIG WhatsApp chat group to look for replacement
5. The Convenor has the discretion to accept late enrolments after the closing deadline as it sees fit.
6. Unless the activity is cancelled due to unforeseen circumstances, low enrollment or bad weather, no refund for withdrawal will be entertained after the enrollment has been processed.
7. Bad weather arrangement: The activity will be cancelled if typhoon signal no. 8 or above / Black rainstorm warning is hoisted 2 hours prior to assembly time.
8. The Convenor reserves the right to change the venue and date of the course due to unforeseen circumstances.
