Fee:	<b>\$255</b> ( <i>inclusive of 4 games and light refreshments</i> )
Eligible player:	HKICPA members only
Capacity:	Min 16 (max 20)
Format:	<ul style="list-style-type: none"><li>Four games for each contestant.</li><li>No handicap will be considered in scoring.</li><li>There will be 3 grades, namely A, B and C. The average score of the 4 games played will determine which "grade" a contestant will be competing in. Equipment:	<ul style="list-style-type: none"><li>Shoes rental is available at \$14 per pair at SCAA.</li><li>Contestant can bring their own bowling equipment if they wish.</li></ul>
Prizes:	<ul style="list-style-type: none"><li>Champion, 1st Runner-Up and 2nd Runner-up for <b>each grade</b>.</li><li>Award for "Overall Single Highest Scoring Game" for men and women. (<i>Prize presentation will be held immediately after the competition.</i>)</li></ul>
Remarks:	Contestant's results will be used as reference for the selection of representative team members for future external competitions including the Recreation and Sports Club for HK Professional Bodies Tournament.
