Exemption of charitable institutions and trusts of a public character (i.e. charities) from tax is granted by the legislature. Section 88 of the Inland Revenue Ordinance provides that a charity is exempt from profits tax subject to certain conditions to be fulfilled in relation to the trade or business carried on by the charity concerned.

The Inland Revenue Department (IRD) recognised the needs to provide more clarities on the taxation of charities in Hong Kong and therefore released in April 2020 an updated tax guide (Tax Guide) for charitable institutions.
