Update on the Mainland China individual income tax reform – Annual reconciliation filing

March 1, 2020 marks the start of the first annual reconciliation filing for individual income tax (IIT) on year 2019's comprehensive income. The annual IIT declaration of foreign income for resident individuals in China has also began.
