IRD's guidance on tax issues arising from COVID-19 pandemic

About the topic

The impact of the COVID-19 pandemic has been broad and deep, affecting, among other things, the ways in which businesses operate and the locations where people work. These changes give rise to tax implications, including issues relating to tax residence of companies and individuals, permanent establishment, employment income of cross-border employees and transfer pricing. Recently, the Inland Revenue Department (IRD) has released guidance on its website to outline its general approaches in handling the tax issues arising from the pandemic.
