# The latest focus of IRD's review on charities

## About the topic

The Inland Revenue Department (IRD)'s practice in reviewing charitable organisations' tax exemption status continues to evolve. Many tax-exempt charities are not aware that their exemption status does not automatically exempt all of their income from tax and, as a result, may overlook their reporting and withholding obligations. More and more issues are falling on the IRD's radar screen, and the number of charities affected continues to increase. Any non-compliance with tax obligations may result in penalties, including for charities. Tax-exempt charities should therefore stay alert to the IRD's latest practice.
