Tax data management and transformation

About the topic

Today's unprecedented economic challenges have forced companies to rethink the way they do business. For many, this includes taking a closer look at how they manage their compliance obligations on a worldwide basis. Managing tax and statutory compliance in today's highly complex economic and regulatory environment is no easy task. Rapid globalization, new developments in tax laws, changes in accounting standards and increased demands from tax authorities are all increasing the burden on tax and finance departments. In addition, the recent global pandemic has taught us all the importance of remote working and building a team that can adapt to challenging circumstances. All the while tax functions are under pressure to provide more and better reporting and compliance, in less time.

Earlier this year, the Inland Revenue Department (IRD) announced the preliminary edition of the IRD Taxonomy Package for electronic filing (e-filing) of profits tax returns. It is planning to launch voluntary e-filing of profits tax returns, together with financial statements and tax computations, in inline eXtensible Business Reporting Language (iXBRL) format in April 2023.
