## Anti-Money Laundering and Counter-Financing of Terrorism ("AML/CFT")

Licensed corporations, such as securities brokers and asset managers, should identify and assess money laundering and terrorist financing ("ML/TF") risks to which they are exposed, so as to facilitate the design and implementation of adequate and appropriate AML/CFT policies, procedures and controls that are commensurate with the ML/TF risks identified in order to properly manage and mitigate them, and ensure compliance with the relevant statutory and regulatory requirements.

This webinar will cover:

- the latest AML/CFT regulatory developments with a focus on the key ML/TF threats and vulnerabilities that are relevant to the securities sector; and
- the findings and observations on AML/CFT identified from the SFC's inspections of licensed corporations, as well
  as recent enforcement actions taken against licensed corporations for breaches of AML/CFT regulatory
  requirements,

to facilitate an understanding of possible internal control failures and non-compliances with the AML/CFT regulatory requirements, and the expected AML/CFT regulatory standards of licensed corporations.
