 - 7~8 堂: 完成導師指定 Singing Task (學生自由選曲配合主題)
 - 9~10 堂: 學生需於導師安排的 "難度挑戰表" 內選曲,為演出準備或作預演之用
 - 11 堂(演出): 學生需於導師安排的 "難度挑戰表" 內選曲演出,並與本校其他學員作交流,容許撞歌正面交流

Register as a Singing Interest Group (SgIG) member

- 1. These courses are arranged by Carol Chan and Caxton Kwong, and you will be registering and making payment directly to them.
- 2. Registration is on a first-come first-served basis. Priority for enrolment will first be offered to SgIG members and then to non-SgIG HKICPA members in the case of over subscription.
- 3. This event is subject to cancellation should the minimum number is not reached.
- 4. Full payment must be made directly to the Instructor upon confirmation of your enrolment.
- 5. The instructor has the discretion to accept late enrolments after the closing deadline as it sees fit.
- 6. Unless the activity is cancelled due to unforeseen circumstances, low enrolment or bad weather, no refund for withdrawal will be entertained after the enrolment has been processed.
- 7. Bad weather arrangement: The activity will be cancelled if typhoon signal no. 8 or above / Black Rainstorm Warning is hoisted 2 hours prior to the commencement of the course.
