The Institute's Audit Practice Manual (2022 edition) ("APM 2022") is a reference tool with customizable documentation templates and an example audit file. It allows users to tailor their audit approach and procedures based on the specific circumstances of an audit client, and assists them to comply with relevant Hong Kong Standards on Auditing (HKSAs). This webinar will provide an overview of APM 2022 and walkthrough the use of the manual from audit planning to completion. The speaker will discuss the manual's approach to an audit of financial statements; the application of selected audit programmes and how they address certain requirements of HKSAs, in order to refresh participants' core auditing knowledge and promote the effective use of the manual.

This webinar will not discuss relevant HKSAs in-depth. It will focus on the application of APM 2022 in an audit of financial statements and assume participants have fundamental knowledge in auditing.
