## **ABOUT THE E-learning**

In October 2020, the Institute issued an exposure draft for PN 820 (Revised), *The Audit of Licensed Corporations and Associated Entities of Intermediaries*. PN 820 has been revised to put more emphasis on risk assessment and based on that to provide additional guidance on how risk assessment should drive the extent of audit work for licensed corporations. The overall structure of PN 820 has been streamlined. More guidance on the use of information technology and various other updates have been added. The webinar will provide an overview of the structure of the revised PN and explain the rationale for the revisions made. The speakers will also share some examples of challenges encountered by auditors of licensed corporations.
