

E-learning: The revised standard on group audit engagements

COURSE HIGHLIGHTS:

In 2022, the IAASB published a revised standard on ISA 600. It introduces significant changes to the audit of group financial statements for periods beginning on or after 15 December 2023, with early adoption permitted. Following these changes, the Institute has released HKSA 600 (Revised), *Special Considerations—Audits of Group Financial Statements (Including the Work of Component Auditors)*, which aligns with the IAASB’s ISA 600 (Revised) and has the same effective date.

One of the significant changes in HKSA 600 (Revised) is the adoption of a risk-based approach for planning and performing a group audit engagement, which results in greater alignment with HKSA 315 (Revised 2019) and HKSA 330. The revised standard also clarifies how requirements in HKSA 220 (Revised) apply to managing and achieving audit quality in a group audit, including sufficient and appropriate resources to perform the engagement, and the direction and supervision of the engagement team and the review of its work. Other key changes include revising the definition of a component; strengthening the communication between the group auditor and component auditor; enhancing documentation requirements; clarifying restrictions that might exist such as access to people or information and providing guidance to overcome them.

This e-learning aims at introducing key changes resulting from HKSA 600 (Revised). Speakers will provide an overview of the standard, explore key changes from current practices and their impact to group audit engagements.

Additionally, speakers will highlight changes to the Institute’s *Code of Ethics for Professional Accountants* relating to the definition of engagement team and group audits, which align with the changes in HKSA 600 (Revised). These revisions to the Code strengthen and clarify the independence principles that apply to individuals and firms engaged in a group audit engagement.
