



## Live webinar: Navigating Hong Kong Risk-based Capital: Key Considerations for Upcoming Annual Submission

The Risk-based Capital regime for Hong Kong insurance industry (HKRBC) came into operation on 1 July 2024, following the commencement of **Insurance (Amendment) Ordinance 2023** and the relevant subsidiary legislation, as well as the promulgation of new or revised guidelines by the Insurance Authority (IA).

The first annual submission to which the new HKRBC regime applies will cover the reporting period ended on 31 December 2024. Under the HKRBC regime, specifically under the Insurance (Submission of Statements, Reports and Information) Rules (Cap.41S), an authorised insurer is required to submit an auditor's report on the specified forms included in the annual returns to the IA.

Following the two informative live webinars held in October and November 2024, which addressed key features, participating fund management and implementation issues of HKRBC, we are now organising an additional live webinar focusing on the annual submission to IA. Given that the first annual submission will be due in June 2025, adequate preparation work is paramount to ensure compliance. In this live webinar, our speakers will share their practice experience and recommendations on effectively completing the annual submission. The webinar will also include a separate session dedicated to answering participants' questions regarding the practical matters encountered during the preparation of the annual submission. Participants are therefore encouraged to take this opportunity to prepare any questions they may have for this interactive session.
