1. 《中國會計年鑒》2024 年卷 Accounting Yearbook of China 2024

創刊於 1996 年，《中國會計年鑒》由財政部主管、中國財政雜誌社編輯出版，為系統化匯輯全國財務、會計工作重要資訊的大型工具書，集權威性、全面性、系統性、資料性於一身。於 2010 年和 2014 年獲得全國年鑒編纂出版質量綜合特等獎，是年鑒界的最高榮譽。

《中國會計年鑒》2024 年卷的內容主要涵蓋 2023 年度國家、行業(部門)、地方和企業的財務會計工作、註冊會計師工作、資產評估工作、會計理論研究、會計教育、重要法規、財會統計資料、會計組織機構和人員、會計大事記等。年鑒附有光碟，方便讀者查閱。

2. 《中國稅務年鑒》2024 年卷 China Taxation Yearbook 2024

《中國稅務年鑒》於 1993 年創刊，由國家稅務總局主管主辦、中國稅務出版社編輯出版，是記錄中國全年稅收工作情況的大型文獻資料性年刊。

《中國稅務年鑒》2024 年卷全面、系統地記述 2023 年度全國及地方稅收工作情況、稅收工作的方針、政策、法規、統計數據、重要文獻、機構和人員等相關資料。年鑒內容由國家稅務總局及全國稅務系統單位所提供。年鑒附有光碟，方便讀者查閱。
