1. Enrolment for the activity is accepted on a first-come-first served basis. Priority will be given according to the order of young members (i.e. aged 40 or below), Sports and Recreation Interest Group members and guests in the case of over-subscription. Non-members' applications will only be processed together with a member's enrolment, and their applications will be considered separately after the closing date for enrolment subject to availability.
2. No telephone reservation will be accepted.
3. The closing date for enrolment is **19 January 2026**. However, the Institute has the discretion to accept late enrolments after the closing deadline as it sees fit.
4. Successful registrants will receive confirmation by email.
