Master (2 pax. per table)		11:00 a.m. – 1:00 p.m.	For member who have joined intermediate level and are recommended by the coach.

6. Unless the activity is cancelled due to unforeseen circumstances, low enrolment or bad weather, no refund for withdrawal will be entertained after the enrolment has been processed.
7. Bad weather arrangement: The activity will be cancelled if typhoon signal no. 8 or above / Black Rainstorm Warning is hoisted 2 hours prior to the commencement of the course.
