

HKICPA E-Learning Series: Towards an Effective and Efficient Audit

Recent inspections by the Accounting and Financial Reporting Council (AFRC) have identified deficiencies in auditors' procedures related to these areas. To enhance audit quality, auditors must thoroughly understand the relevant requirements to design and perform appropriate audit procedures, ensuring an effective and efficient audit.

Drawing on findings from recent AFRC inspections, speakers will discuss relevant requirements in the Hong Kong Standards on Auditing (HKSA) with illustrative examples to highlight common pitfalls and offer tips for avoiding them in practice.
