Non-members' applications will only be processed together with a member's enrolment, and their applications will be considered separately after the closing date for enrolment subject to availability.
2. No telephone reservation will be accepted.
3. The closing date for enrolment is **20 September 2024**. However, the Institute has the discretion to accept late enrolments after the closing deadline as it sees fit.
4. Successful registrants will receive confirmation by email.

6. Bad weather arrangement: The activity will be cancelled if typhoon signal no. 8 or above / Black Rainstorm Warning is hoisted 2 hours prior to the commencement of the event
