 Judges' decisions are final and no appeal will be entertained.
- The duration of each dance is approximately 2 minutes.
- The entire competition including prize presentation will take place at the Dance Fun Night on 14
 October 2017. First, second and third place will be awarded with trophies/medals.
- No entry fee is required to enter into this members' competition.
- Deadline for entry is <u>25 September 2017</u>.
- The competition will be cancelled if there are less than 4 entries for each category. Subject to the final number of entries, the competition may be divided into preliminary and final rounds to be held in the same evening.
