1. Priority for enrolment will first be offered to TsIG members and then to non-TsIG HKICPA members in the case of over-subscription. Non-members' applications will only be processed after registration deadline subject to availability. We only consider non-member's enrolment when it is enrolled with a member.
2. The event is subject to cancellation should the minimum number is not reached.
3. Availability of venue will be confirmed by the coach in the **preceding Wednesday** subject to venue availability. The dates shown above are for indicative purpose.
4. The duration of each lesson is subject to the venue availability. Each lesson will be at least 1.5 hrs and the course will comprise of 8 hrs in total.
5. Full payment must be made before your enrolment will be processed. No telephone reservation will be accepted and cash is strictly NOT accepted.
6. The closing date for enrolment is **17 October 2017**. However, the Institute has the discretion to accept late applications as it sees fit.
