The latest China administrative guidance on withholding tax

The State Administration of Taxation ("SAT") has recently issued a new guideline on the administration of withholding tax (WHT). The guideline, in brief, replaces a number of prevailing WHT requirements, allows a more flexible timeframe to settle WHT payments and discusses further obligations of WHT agents and recipients. Tax practitioners generally welcome the guidance, although there are still some areas in need of further clarification by SAT to provide greater certainty to taxpayers.

In this seminar, the speaker will discuss the underlying changes compared with the previous practices and how to address the areas of uncertainty, using case studies to illustrate.
